

Important Dates and Deadlines

Fall 2011/Spring 2012

- July 22** **Financial aid documentation and forms due in order to meet Fall tuition payment due date and ensure book vouchers will be available before school starts.**
- Information received after this date may not be processed to meet payment deadlines. Options to retain registration include: payment in full and tuition payment plan. Students who have paid or paid partial payment will still be considered for financial assistance.*
- July 27 First tuition payment due for the Fall 2011 semester.
- (Consult the course schedule for additional registration and tuition due date information.)*
- August 1 Financial aid (grants/scholarships/student loans) recipients may begin requesting book vouchers for Fall 2011. Be sure you bring a copy of your schedule and picture ID.
- August 22 Fall Semester classes begin.
- September 9 Last day to defer books to financial aid for the fall semester
- September 13 Last day to apply for a student loan for the 1st disbursement the week of September 23rd. All necessary steps must be successfully completed to process the loan.
- September 23 Anticipated first mailing of Student Loan Checks for the fall semester.
You will receive your student loan in two installments. Your loan money must first be applied to pay for tuition, fees, bookstore charges and other school charges. If loan money remains, you'll receive the funds by check.
- October 7 Anticipated first mailing of Pell Check Refunds for the fall semester
- October 17 Online registration for the Spring 2012 semester begins
- October 21 Last day to apply for a student loan for the fall semester.
- October 24 In-person registration begins for Spring 2012 semester
- October 28 Last day to submit appeals for the Fall 2011 semester; includes SAP appeals, Special Circumstances, and Dependency Appeals
- November 3 Final loan check disbursements mailed
- November 30 First tuition payment due for the Spring 2012 semester. *(Consult the course schedule for additional registration and tuition due date information.)*

December 1 **Financial aid documentation and forms due in order to meet Spring 2012 tuition payment due date and ensure book vouchers will be available before school starts.**

Information received after this date may not be processed to meet payment deadlines. Options to retain registration include: payment in full and tuition payment plan. Students who have paid or paid partial payment will still be considered for financial assistance.

December 20 Academic progress reviewed for the Fall 2011 semester financial aid recipients.

Students who are not in compliance will be notified by mail of loss of financial aid beginning Spring 2012 semester. Students have the right to appeal termination of financial aid due to unsatisfactory academic progress.

December 22 The last date the Financial Aid Office can complete processing prior to the end of a semester.

February 27 Anticipated first mailing of Pell Check Refunds for the spring semester.

March 16 Deadline for student loan applications for the spring semester.

March 28 Final loan check disbursements mailed.
